CREOLE'S AFFAIR stalked the pace, moved to the front entering the stretch and edged clear under firm handling. CIGAR BREAK saved ground, advanced on the far turn, swung five wide into the stretch and closed ground willingly. BORDER CAT brushed at the start, was urged around the far turn, moved four wide into the stretch and kept on. AND THE BEAST displayed mild late interest. TRACY'S SPOUSE passed tiring rivals. WILD COMEDY failed to menace. FORCED ACTION saved ground and managed no rally. ADVANCED SIGNS leaned out at the start, was urged on the far turn, moved out seven wide into the stretch and made no bid. TAKE ME TO MERANO gained the early lead, was headed leaving the far turn and gave way. PENALTY KICK was outpaced while five wide and faded. LAVA ON THE RUN was always outrun. HALFA TONA ORNERLY showed brief speed and faltered.
